The 2025 Churchwide Assembly of the Evangelical Lutheran Church in America (ELCA) reconvened in Hall E of the Phoenix Convention Center, Phoenix, Ariz., at 10:16 a.m. (all times Pacific Daylight Time unless otherwise noted). The Rev. Elizabeth A. Eaton, presiding bishop of the Evangelical Lutheran Church in America (ELCA), called the assembly to order.

#### Elections: Results of First Ballot for Presiding Bishop

Mr. Thomas A. Cunniff, general counsel for the ELCA and chair of the Elections Committee, presented the initial results of the first ballot for presiding bishop. Of the 667 legal ballots cast, none of the nominees received the 501 votes necessary for election. Those who received votes were able to withdraw their names from the second ballot. Urge Augsburg Fortress and the Service and Justice unit, in consultation with other appropriate churchwide organization home areas, to create adult and children/youth educational programs and materials concerning Christian and Lutheran roles in Indian boarding schools to broaden and deepen awareness at congregations, synods, and ministries affiliated with or related to the ELCA; and to consistently publish articles in all of this church’s publications;
3. Provide on-going recognition of and support for the growing network of lay people and rostered ministers volunteering their time in the work of the ELCA Truth-Seeking and Truth-Telling Initiative on Indian Boarding Schools (see [www.elca.org/IndianBoardingSchools](http://www.elca.org/IndianBoardingSchools)) to locate all known records related to the ELCA’s predecessor bodies’ involvement with Indian boarding and day schools and to educate others about Indian boarding schools;
4. Encourage ministries affiliated with or related to the ELCA to commit to learning the truth of their involvement with Indian boarding schools, in partnership with the ELCA Truth-Seeking and Truth-Telling Initiative and to responsibly create paths to healing and repair;
5. Organize and care for all information in the ELCA’s possession that was recorded about Indian boarding and day schools and the students who attended them, forcibly or otherwise; carry out this work in partnership with the ELCA Truth-Seeking and Truth-Telling Initiative and the ELCA Archives; recognize that this information belongs to and is a source of healing for student survivors, their descendants, communities, and Tribal Nations;

- and ensure that the records and research are made accessible to Indian boarding school survivors and their families in a responsible manner; and
6. Direct the churchwide organization to identify the revenue source(s) to sufficiently support research and organizing efforts, and to sufficiently support digitization and labeling of all Indian boarding school records in the ELCA Archives.

WHEREAS, 2025 is the 1700th anniversary of the first ecumenical Council of Nicaea, and a year in which we will celebrate a common date for Easter, which presents a unique opportunity for reconciliation between Eastern and Western Christianity; and

WHEREAS, the end-result of the Council of Nicaea—later expanded in 381—was the Nicene-Constantinopolitan Creed, which has served as a common confession of faith for Christians around the world ever since; and

WHEREAS, the addition to the Nicene-Constantinopolitan Creed of the *filioque*—meaning “and the son”—by the Latin Church in an attempt to resolve a dispute, resulted in the division between the Eastern and Western churches in the year 1054; and

WHEREAS, in 1999, talks between the ELCA and the Standing Conference of Canonical Orthodox Bishops in the Americas arrived at “A Lutheran-Orthodox Common Statement on Faith in the Holy Trinity,” coming to a shared understanding of history and the emphases of each tradition with regard to the creed; and

WHEREAS, in 2006, the ELCA Church Council adopted “A Lutheran-Orthodox Common Statement on Faith in the Holy Trinity,” and *Evangelical Lutheran Worship* was published with a footnote to the Nicene Creed that says it is appropriate to confess the creed without the phrase; and

WHEREAS, the ELCA is a member church of The Lutheran World Federation (LWF), and the LWF has been in dialogue with the Orthodox Church for more than forty years; and

WHEREAS, in 1990, at the Eighth LWF Assembly in Curitiba, the LWF approved omitting the *filioque* clause in ecumenical services when the Orthodox Church is present, setting a precedent later adopted by other world communions; and

WHEREAS, in 2024, the Joint International Commission on Theological Dialogue between the LWF and the Orthodox Church affirmed a “Common Statement on the *Filioque*,” affirming that the *filioque* is not a church-dividing issue and encouraging renewed theological reflection on the Trinity and the role of the Holy Spirit, which was adopted by the LWF Council that June; and

WHEREAS, this Common Statement presents a ground-breaking opportunity to understand our history in light of our dialogue with the Orthodox, and to begin to heal millennium-old divisions in the body of Christ; therefore, be it

**RESOLVED**, that the ELCA prayerfully engage in commemorating the 1,700th anniversary of the first ecumenical council at Nicaea, and the common date of Easter,

as an opportunity for continued theological reflection on the Trinity and the role of the Holy Spirit and reconciliation between the Western and Eastern churches; and be it further

**RESOLVED**, that the 2025 Churchwide Assembly prayerfully receive the 2024 Lutheran-Orthodox “Common Statement on the *Filioque*,” understanding such reception to be an intention to lean into a fuller understanding of this issue and the promise of greater unity in the Body of Christ.

The 2025 Churchwide Assembly of the Evangelical Lutheran Church in America (ELCA) reconvened in Hall E of the Phoenix Convention Center, Phoenix, Ariz., at 9:02 a.m. (all times Pacific Daylight Time unless otherwise noted). The Rev. Elizabeth A. Eaton, presiding bishop of the ELCA, called the assembly to order.

### Elections: Third Ballot for Secretary

The Credentials Committee reported that, as of 9:55 a.m., 803 voting members had registered to cast ballots. Presiding Bishop Eaton called on the assembly to cast the third ballot for secretary.

### Elections: Results of Third Ballot for Secretary

In our contemporary context, this church recognizes that white supremacy, in both its historical and present-day forms, is a structural sin that has shaped civic life, governmental institutions, and religious structures. Such systemic sins are particularly horrendous because the things done and left undone dramatically deepen the oppression of other people.”

And Article 38, at line # 1478, insert “supremacy” for “superiority”:

“This privileging of white, U.S.-born Christians is connected to our country’s violent practices of white supremacy, such as Jim Crow laws or the hundreds of years of Black African slavery.”

This happens when, for example, a person diminishes their own contributions to human life or denies that they possess the dignity and value of every human being created in God’s image.”<sup>10</sup>”

fn. 10: This reference to sin addresses cases where individual and systemic patterns have perpetuated great harm through internalized inferiority of different kinds, especially among those who have been marginalized in our society because of their race, class, gender or sexual identity, to name but a few categories. As a result of our broken trust in God, human relationships also become broken and distorted. This reference is not directed at cases of diminished self-worth that are all too familiar to anyone who has experienced depression, anxiety disorders, or cared for someone with a mental illness. For more guidance in these complex cases, see the social messages “The Body of Christ and Mental Illness” (2012) and “Faith, Sexism, and Justice: A Call to Action” (2019).

This church supports the work of advocacy, accompaniment, and the reimagining of public systems so that all people, especially those historically excluded, may share in shaping the life we hold in common.”

7. To encourage synod leaders, in collaboration with other appropriate bodies, to explore creating or expanding state public policy advocacy in their domains as part of the ELCA Witness in Society network, similar to those already existing in several states;

To direct the churchwide organization, in consultation with the Conference of Bishops, theologians and ethicists, and rostered ministers, as well as elected lay leaders, to develop guidelines and protections consistent with this social statement regarding the roles in civic life of representatives of this church with official responsibility to preach, teach, and lead on behalf of this church;

To call upon the publishing and educational ministries of this church, including but not limited to Augsburg Fortress Publishers, to consider the need for civics education curricula, civic participation guidance, and related theological reflection, and to create these in multiple formats, including multimedia and online;

To call upon the publishing and educational ministries of this church, including but not limited to Augsburg Fortress Publishers, to explore the need for resources dedicated to nonviolent resistance and peaceful engagement in civic life, with special concern for materials dedicated to religious and political histories, liturgical guidance, and training for rostered and lay leaders;
11. To direct the Witness in Society team of the churchwide organization and call upon all expressions of this church in their advocacy efforts to support and advocate for policies and laws consistent with this social statement and to give sustained attention to the fresh convictions and commitments found here in its creation of programs and projects;
12. To direct the Ecumenical and Inter-religious Relations team in the Office of the Presiding Bishop to share this statement as a resource for dialogue, discernment, and collaboration with ecumenical and inter-religious partners toward the well-being of all people and creation from within the U.S. context;
13. To urge faculty, staff, and administrators of ELCA-related colleges, universities, and seminaries to renew and emphasize education toward callings in public service and to model and encourage dynamic civic participation among their students;
14. To direct appropriate units in the churchwide organization, coordinated by the Office of the Presiding Bishop, to establish or oversee processes for implementation of these resolutions, with an initial report to the Fall 2027 meeting of the Church Council.

The 2025 Churchwide Assembly of the Evangelical Lutheran Church in America (ELCA) reconvened in Hall E of the Phoenix Convention Center, Phoenix, Ariz., at 11:00 a.m. (all times Pacific Daylight Time unless otherwise noted). The Rev. Elizabeth A. Eaton, presiding bishop of the ELCA, called the assembly to order.

### **Motion J: Resolution on AI in the Church**

**Submitted by: William Platnick [Upstate New York, 7D]**

Whereas, we believe that “God created humankind in [God’s] image” (Genesis 1:27) and that every human being bears the *imago Dei*, endowed with intrinsic dignity, creativity, and moral responsibility;

Whereas, the ELCA’s social message *Faith, Science and Technology: Environment, Medicine, and Genetics* reminds us that “God works through human creativity,” and calls the church to exercise wise stewardship of all God-given gifts;

Whereas, artificial intelligence (AI)—broadly defined as computer systems capable of tasks once thought to require human intelligence—has seen rapid advances in areas such as language processing, decision-making, and pattern recognition, with profound implications for work, relationships, worship, and public life;

Whereas, AI raises urgent ethical and theological questions around human dignity, agency, bias, privacy, justice, the nature of vocation, and the safe deployment of powerful new tools—especially for those most vulnerable to technological displacement or surveillance;

Whereas, AI-driven automation threatens to displace workers across industries, exacerbating economic inequity and calling the church to stand in solidarity with those affected;

Whereas, congregations, rostered leaders, and church institutions increasingly encounter AI-driven tools in pastoral care, education, administration, and global mission, yet lack consistent frameworks to discern where such tools may augment human ministry—and where they risk undermining the Gospel and human flourishing;

Whereas, the ELCA Churchwide Assembly has called for ongoing socio-ethical reflection on emerging technologies and directs its Division for Church in Society to resource this church in engaging public policy, advocacy, and education;

Therefore, be it resolved, that the Evangelical Lutheran Church in America:

1. Affirms that human beings alone—created by God, redeemed in Christ, and guided by the Holy Spirit—remain the ultimate bearers of moral responsibility; no AI system can replace the vocation, compassion, or discernment entrusted to God’s people.
2. Directs the ELCA Division for Church in Society, in partnership with the ELCA Advocacy Office and the seminary network, to develop and publish by March 2026:
  - A concise “AI and Faith” study guide for small groups and adult forums, with discussion questions rooted in Lutheran theology.
  - Ethical and Safe-Use Guidelines for AI in worship planning, pastoral care tools, educational settings, administrative functions, and social ministry programs—emphasizing transparency, accountability, data privacy, bias mitigation, and safeguards against unintended harm.
3. Encourages all ELCA councils (congregational, synod, and churchwide) to utilize the following Values Framework—originally adopted by the PC(USA) 226th General Assembly—in order to interpret and apply the Ethical and Safe-Use Guidelines (see 2) as they arise in new or unanticipated contexts, while more comprehensive policy is under development:
  - a. Recognize the fundamental, inherent dignity of every human.
  - b. Ensure no human or human community is subjected to harm at any stage in the AI lifecycle, and mitigate disruptive impacts.
  - c. Acknowledge AI’s potential to assist at every stage of the human life cycle.
  - d. Insist on preservation, promotion, and expansion of fundamental freedoms and rights for individuals and communities in AI-assisted contexts.
  - e. Implement environmental and ecosystem safeguards to ensure the flourishing of creation.
  - f. Foster participative and enabling roles for all actors, in building peaceful and just societies.
  - g. Promote peace, inclusivity, justice, equity, and interconnectedness throughout the AI lifecycle.
  - h. Commit to engaging AI’s broader implications in a theologically responsible manner.
4. Encourages ELCA seminaries and partner institutions to establish or expand interdisciplinary courses and research initiatives at the intersection of theology, ethics, computer science, and social justice—preparing future rostered ministers and church professionals to navigate AI’s challenges faithfully and safely.
5. Urges the ELCA to:
  - Advocate, with ecumenical and interfaith partners, for public policies that protect workers displaced by automation, uphold data privacy, prohibit lethal autonomous weapons, and promote responsible innovation.

- Partner with global companion churches to ensure AI-enabled tools (e.g., translation, health diagnostics, educational platforms) advance the gospel, human well-being, and equitable access, rather than entrench existing inequities.
6. Requests that by the 2028 Churchwide Assembly, the Church Council report on progress made, lessons learned, and recommend any further actions needed to ensure ELCA ministries remain rooted in the Gospel, responsive—and safe—in an age of rapid technological change and ecological challenge.
